## ORDER ON RECEIVER'S FIFTH MOTION FOR APPROVAL OF SETTLEMENTS WITH THIRD-PARTY DEFENDANTS/LICENSEES

On the 25 day of April, 2013, the Court heard the RV Receiver's Fifth Motion for Approval of Settlements with Third-Party Defendants/Licensees Ronald James, Donald James, Michael Beste, James Settlement Services, LLC, Milkie/Ferguson Investments, Inc., Edward Milkie and Manny Aizen ("Defendants"). It is further ORDERED ORDERED that the claims of Milkie/Ferguson Investments, Inc., Edward Milkie and Manny Aizen against Retirement Value, LLC, Eduardo S. Espinosa, and Eduardo S. Espinosa in his capacity as Receiver for Retirement Value, LLC are dismissed with prejudice.

It is further ORDERED ORDERED that the claims of Milkie/Ferguson Investments, Inc., Edward Milkie and Manny Aizen against Wells Fargo Advisors, LLC, Wells Fargo Investments, LLC, Wells Fargo Bank N.A., Whitney Giles (Martin) and Wells Fargo Wealth Brokerage Insurance Agency, LLC are dismissed without prejudice.
