**AMENDED AND UNOPPOSED MOTION TO AUTHORIZE  
A SECOND INTERIM DISTRIBUTION PURSUANT TO  
THE PLAN OF DISTRIBUTION**

**Pursuant to the Court's instructions, any party wishing to object to the relief requested in this motion must file and serve a written objection. All objections must be in writing and filed on or before March 11, 2016. If no objections are received by that date, then the Court may, at its discretion, grant the motion on submission without an oral hearing.**

Eduardo S. Espinosa, in his capacity as the court-appointed Receiver for Retirement Value, moves this Court for authorization to make a second Interim Distribution<sup>1</sup> to the Investors pursuant to § VII of the Plan of Distribution. Although identical in substance, this motion supersedes the Receiver's Motion to Authorize a Second Interim Distribution filed on February 23, 2016.

## **SUMMARY**

The Receiver seeks permission to make a second Interim Distribution of \$2,500,000. The distribution will be split among the investor classes as follows: \$2,372,170 to the RV Investors and \$127,830 to the HCF Investors. The proposed distribution is authorized by the Plan and is in the best interest of the estate.

## **STATUS OF CLAIMS PROCESS**

The Receiver compiled and filed with the Court the Schedule of Claims required by the Plan of Distribution (the “Schedule”). The Schedule lists all of the claimants of Retirement Value and HCF, the amount claimed by each person, the classification of each claim and whether the Receiver approves or disputes the claim. The Schedule reflects all investor claims as Class 2 Claims. All disputes pertaining to Class 2 Claims have been resolved and all Class 2 claim constitute Approved Claims under the Plan of Distribution.

The Sixth Amended and Restated Schedule of Claims<sup>2</sup> reflects all of the adjustments to the Schedule of Claims arising out of: (i) the proof of claim process and the resolution of any claim related disputes; (ii) settlements; (iii) the claimants' voluntary transfer, assignment and conveyance of their interests of which the Receiver has received notice and (iv) transfers occasioned by the death of an Investor. Standardized forms for notifying the Receiver of such assignments and for naming beneficiaries are posted on the forms page of the estate's website at [www.rvllcreceivership.com](http://www.rvllcreceivership.com).

## **THE PROPOSED DISTRIBUTION**

The Receiver seeks permission to distribute \$2,500,000 to the Investors pursuant to the Plan. After making the distribution, the Receiver will retain sufficient funds to pay premiums on the portfolio and to maintain expected receivership operations. The proposed distribution is proper and in the best interest of the estate.

Pursuant to the Plan, the Receiver may not make a distribution unless he has sufficient funds on hand to maintain adequate reserves to pay the anticipated premiums due on the Policies. Plan at § VI.B.3. Reserves are adequate “if they are at least equal to (a) the needed premium reserves calculated at the 97½ percentile in the most recent stochastic model prepared by the Receiver’s actuaries plus (b) the amount calculated by the Receiver as necessary to meet anticipated future expenses.” *Id.*

According to the stochastic analysis, the needed premium reserve calculated at the 97½ percentile is \$12,815,246 as of December 31, 2015. Of note, the needed premium reserve calculated at the median or 50th percentile is \$3,549,470 and the needed premium reserve calculated as an average of all results in the stochastic analysis is of \$4,433,736. The results of Lewis & Ellis’s analysis are attached as Exhibit A. Like the previous actuarial reports which formed the basis for the initial and first interim distributions, this stochastic analysis was performed based on the historical life expectancies acquired by the Receivership from ISC in the 4th quarter of 2010.

Lewis & Ellis also prepared a stochastic analysis based on a separate set of life expectancies that were subsequently acquired from AVS. The AVS LE's extend the insureds' projected longevity and increase the portfolio's reserve requirements accordingly. The results of the second analysis suggest premium reserves of (i) \$17,446,830 at the 97½ percentile; and (ii) \$5,372,180 at the median.

The Receiver recommends that the Court continue to utilize the reserves calculated pursuant to the ISC analysis. The Receiver believes that the reserves calculated pursuant to this analysis are consistent with the guidelines set forth in the Plan of Distribution and that the extended longevity risk hinted at by the AVS LE's is substantially mitigated by the estate's ability to borrow additional capital, if necessary. Moreover, the Receiver believes the estate and the defrauded investor victims are better served by making the additional distribution.

In addition, we believe that the reserve requirements are conservative. By reserving at the 97½ percentile, we are building in a significant cushion against unexpected results. In addition, the life expectancies of the HCF insureds are probably overstated. Because we do not have current health information on these insureds, we have been unable to obtain a life expectancy calculation on them. Therefore, we have used standard life expectancies based on the insureds' ages without any discount for health issues. However, old life expectancy calculations that we have obtained on these insureds suggest that each insured does have health issues that may result in a shorter than standard life expectancy.

This approach also comports with historical practice. The Initial Distribution and the first Interim Distribution were based on actuarial analyses using the ISC LE's. At the time of the first Interim Distribution in 2014, the Receiver had his actuaries prepare two stochastic analyses – one using the ISC LE's and one using the AVS LE's. As with the current analyses, the AVS analysis suggested a higher reserve level than the ISC analysis. The reserve level chosen in 2014 was \$300,000 above the 97½ percentile of the ISC analysis and at the 85<sup>th</sup> percentile of the AVS analysis from that time period. The Receiver proposes to maintain similar reserves at this time.

As of December 31, 2015, the Receiver has cash on hand of \$15,423,159. Looking only at the cash on hand, the Receiver has slightly more than \$2,607,913 in excess of the required premium reserve. The Receiver proposes a supplemental distribution of \$2,500,000 and a reserve of \$12,923,159. This will create an excess reserve of \$108,000 to cover non-premium expenses. The proposed reserve level exceeds (i) the 97½ percentile of the current ISC analysis, and (ii) the 92<sup>nd</sup> percentile of the current AVS analysis.

Because the funds to be distributed are not traceable to a cause of action that is owned solely by either the Receiver or the HCF Receiver, the funds will be distributed in accordance with § V.B.1 of the Plan – 94.89% will be paid pro rata to the RV Investors and 5.11% will be paid pro rata to the HCF Investors.<sup>3</sup> This works

<sup>3</sup> The Plan of Distribution calls for 94.7% to be paid pro rata to the RV Investors and 5.3% to be paid pro rata to the HCF Investors. Subsequent to the adoption of the Plan, David Gray assigned his claims of \$144,500 against HCF to the RV Receiver. Mr. Gray's claims represent a 0.186% participation in the distribution which was accordingly reallocated amongst the RV Investors.

out to \$2,372,170 to be split among the RV Investors and \$127,830 to be split among the HCF Investors.

The proposed distribution schedule is attached as Exhibit B. This distribution schedule reflects settlements between the Receiver and certain licensees under which the settling licensees agreed to pay the estate out of distributions that they or their family members receive as investors. The attached payment schedule identifies the Investors whose distributions are affected by settlement agreements and shows the allocation of those distributions between the estate and each such Investor. The payment schedule may change to reflect deaths or assignments of Investor claims between the date of this motion and the Distribution Date.

#### **DISTRIBUTIONS TO DATE**

Upon adoption of the Plan, the Receiver made an initial distribution of \$5,500,000. In January of 2014, the Receiver made the first interim distribution of \$3,000,000. If the Court approves the requested \$2,500,000 distribution, the Receiver will have distributed \$11,000,000 or 13.7% of the total approved Class 2 (investment) claims.

ACCORDINGLY the Receiver requests permission to make an Interim Distribution of \$2,500,000 to the Investors as set forth on Exhibit B.




